

MOAA engages with Congress on all manner of issues related to the uniformed services community. These efforts can include collaboration with other like-minded organizations and with The Military Coalition. We also rely heavily on our members who make their voices heard by contacting lawmakers via <u>MOAA's L Legislative Action Center</u>, by participating in our annual signature advocacy event, and through local efforts at the <u>chapter and council level</u>.

For <u>more than 90 years</u>, this work has led to real results – pay and benefits protected from budget-driven threats, continued access to quality medical care, and countless other areas of concern to our members, our military, and the wider uniformed services community.



#### Level of Excellence Awards

MOAA is pleased to announce the winners of the annual Council and Chapter Levels of Excellence (LOE) Awards for performance in 2022.

Out of almost 400 MOAA affiliates, 169 councils and chapters earned LOE award recognition this year. These councils and chapters excel at supporting and fostering programs that directly support the MOAA mission and their communities.

#### Col. Marvin J. Harris Communications Awards

MOAA renamed the award in 2011 after Colonel Marvin J. Harris, USAF (Ret), Director of Public Relations from 1996 until 2011. Colonel Harris delivered effective communications to both military and civilian audiences. Each year, national MOAA holds a communications award contest to identify those councils and chapters that do an outstanding job communicating with their members and community.

The State Legislature is finalizing this year's long session (the first of a two-year cycle). Back at the beginning of the session, the target is to finalize the session in July, but as disagreements on the budget hit a high note, that end date flew past and it is now thought to end either later this month or in October. Sadly, the focus has not been on any of the bills associated with veteran issues, but a disagreement associated with casinos and an expansion of Medicaid. Since opinions and disagreements abound, not a lot of information is available on the budget negotiations, either on the House or Senate side. Any bill al-ready proposed could make it into the budget directly, but decisions are needed on the bills that made the crossover list (bills approved by one of the legislative houses). Six bills besides the appropriations bill made it on this year's crossover list: HB 178, HB296, HB427, HB463, HB487 & HB492 as well as HB 259 appropriations. The bills associated with property tax adjustments did not make the crossover list this year.

The best possibility for passage still is those with little or no budget implications: HB296 to officially adopt the Veteran history museum of the Carolinas, HB427 Honor Women's Vet DMV License Plate, and HB487 POW/MIA Flags on state owned buildings & public Schools. Some version of the HB178 should be in the budget which deals with the maintenance of state veteran cemeteries, but whether the amount remains consistent with past years or is increased to meet actual needs remains to be seen. Just as a reminder, HB 463 prohibits foreign governments or their agencies from purchases agricultural and other lands critical to the safety and security of the state and HB492 requires businesses to post a notice of veteran benefits they offer.

Next year's session is considered a short session since it is centered around elections. Although new legislation can be considered, during the short session, the norm is to continue working bills that made it to this year's crossover list, corrections and adjustments to the approved budget or appropriations.

## WNC MOAA State Legislative Affairs Update

We continue to support legislative issues for veterans and focus on the three top issues our board approved for the 2-year cycle.

Within the chapter, we did a minor shift of responsibility with Tricia taking the lead role of the state legislature team and Michael going to a supporting role. Mostly a change in name only since we both work together as a team, splitting our communication with our legislatures equally between ourselves. So, you have the same team advocating for our members and fellow veterans with plans to continue our support for the upcoming year.

We wish we had more news on veteran topics, but this year they didn't seem to be a priority with other issues taking most of the state legislature's consideration.

#### Higher TRICARE Fees Part of Testimony From Congressional Budget Office-

"Written testimony submitted by the Congressional Budget Office (CBO) to a recent Senate subcommittee hearing on DoD personnel includes several proposals threatening service-earned benefits, such as the introduction of TRICARE For Life fees and minimum out-of-pocket requirements." (MOAA.org)

#### TAKE ACTION: Tell Congress You Oppose TRICARE/TRICARE for Life Fee Increases]

Please join us once again in providing a counterpoint to CBO's written testimony by reminding Congress that our nation has an obligation to provide the health care benefit servicemembers and retirees have earned. You can read more about the proposals <u>at this link</u>, but the bottom line remains stark:

- Proposed TRICARE For Life enrollment fees would cost Medicare-age beneficiaries \$575 a year for individual coverage or \$1,150 for family coverage.
- Proposed cost-sharing measures would include an \$850 deductible, meaning TRICARE For Life would not cover any of the first \$850 of a beneficiary's Medicare cost-sharing.

After the deductible, the proposed cost-sharing plan allows TRICARE For Life to cover only 50% of the next \$7,650 in Medicare cost-sharing, meaning beneficiaries would pay up to \$4,675 in cost-sharing per year.

Registering with <u>MOAA's Legislative Action Center</u> now and <u>sending a message today</u> will not only help prevent TRICARE fee increase concepts from moving ahead, it will ensure you are poised to fight TRICARE fee increases if CBO concepts evolve into legislative proposals.

## Act Fast to Meet a New Deadline for Survivor Benefit Plan Enrollment

While the deadline for a rare Survivor Benefit Plan (SBP) open season remains Jan. 1, 2024, the practical deadline for beneficiaries who want an estimate of what the coverage would cost has moved up a month.

Initial messaging from the Defense Finance and Accounting Service (DFAS) said normal processing time for a Letter of Intent – a document DFAS uses to make a cost estimate –

would be 30 days, meaning interested enrollees would have until about Dec. 1 to send in the paperwork. But an update to the <u>DFAS open season website</u> now lists Nov. 1 as the Letter of Intent deadline. Those who don't send a Letter of Intent by that date may not receive a premium estimate before the Jan 1 enrollment deadline.

## THE PACT ACT

The VA requested that Veteran Service Organizations help spread to word to all Veterans and survivors. Please share this information if you know any military surviving spouse not receiving VA benefits, e.g., DIC.

To file an intent or a claim <u>PACT ACT</u>. August 10, 2023 marks the first anniversary of the passing of the Pact Act. This new legislation is essential because it provides VA benefits to a surviving spouse who was not previously eligible. Since enacting this law, the VA has been working on identifying those surviving spouses who might be eligible. However, they have asked for Veteran Service Organizations to help reach out. MOAA Surviving Spouse Advisory Council is doing much to help with this effort.

The Pact Act recognizes recent presumptive illness that if a service member dies due to this service-connected disability, their beneficiary may be qualified for Veteran Affairs (VA) benefits. These benefits include Dependency Indemnity Compensation (\$1,562.00/month), a home Loan program, education, a Fiduciary program, aid and attendance, and more (VA.gov). If you know a surviving spouse who does not receive DIC, please share the Pact Act information with them. This benefit can change the quality of life of a surviving spouse.

<u>Learn about VA DIC and how to apply</u>. Note: If the VA denied your claim in the past and they think you may be eligible now, they will try to contact you. However, do not wait for the VA to contact you; reapply.

## Henderson County Has A New Veteran Service Officer

Brent Embry, a 22-year veteran of the U.S. Air Force and Navy who retired as a Navy Commander, has been named Henderson County's new Veterans Service Officer.

Commander Embry has big shoes to fill upon the retirement June 30 of Mike Murdock, the county's longtime Veterans Service Officer.

"Caring for the veterans in our community is one of our highest priorities," County Manager John Mitchell said. "I thank Mike Murdock for the incredible job he's done for Henderson

County over the years, and I am confident Brent Embry will carry on the tradition of high-quality veteran services in this county. There are a lot of exciting new opportunities for veterans in our community that will be coming online in the next year, and I know that Brent is the leader who will take us there."

Brent's military career spans nearly 22 years and includes time in the two branches serving as an Aircraft Maintenance and Munitions Officer, a Navy Surface Warfare Officer, Operations Officer, Chief Staff Officer, and Officer in Charge. The positions took him to posts in Arizona, Utah, the Persian Gulf, Florida, Italy, Africa, Lebanon, Rhode Island and Guam.

Since retiring from the Navy five years ago, Brent has lived and worked in Western North Carolina. Before accepting the Henderson County post, he served as the lead Veterans Service Officer for the 12-county western district of the North Carolina Department of Military and Veterans Affairs.

#### A Hero Comes Home To The Mountains

The unfortunate outcome of war is that it reduces people to numbers. War casualties generate reports and sometimes people need to be reminded that each number is a person with a history and a family. In 1969, Air Force Captain Frederick (Freddie) Mervyn Hall had a life, a family, and a new bride when he was declared missing in action serving his country in Vietnam.

February 9, 1978, Captain Frederick Mervyn Hall was declared dead and ceremonially buried with his military uniform in lieu of a body at the Green Hill Cemetery in Waynesville.

After 54 years, on October 10, 2023, the earthly remains of Captain Frederick Mervyn Hall came home to Waynesville, NC, where his memory and spirit have always lived.

Family, friends, Vietnam veterans, and veterans across all services and of all ages gathered at the Waynesville First Presbyterian Church just before 11 AM for memorial services. The service remembered the man and his impact on people throughout his much too short life. His wife, Julia Jean Keith, a native of Houston at the time of his death, attended the ceremony, traveling from Texas.

While stationed at Tucson, he met a University of Arizona art student named Julia Jean Keith, a Texan crowned Miss Houston, in 1965. They were married in Tucson on Dec. 18, 1968, while Hall was still stationed at Davis-Monthan AFB. Two months later, Captain Hall left for overseas duty. At the airport, the last thing he said to her was, "I love you."

Reunited at the Atlanta airport October 8th, 2023, and 54 years of separation now behind them, Capt. Hall was officially welcomed home and laid to rest by family, friends, and the community. Only one thing remained on Julia's wish list, and **Blue Ridge Honor Flight** made that happen. On Saturday, October 14th, 2023, Julia was able to touch the names of , Capt. Frederick M. Hall, and Col. Ernest DeSoto, (Navigator and Pilot, respectively) on the wall of the Vietnam War Memorial.

#### Buncombe County Veteran Treatment Court - "No Veteran left behind."

Buncombe County, N.C. – On 20 August 2023 Buncombe County demonstrated its commitment to leaving no veteran behind. Three veterans graduated from the county's 18-month Veterans Treatment Court (VTC) Program. The 18-month program challenges veterans to an intense stay clean, work-hard, opportunity-based alternative to a felony stint in a correction facility.



The Veterans Treatment Court utilizes a non-adversarial, team approach to providing services and supports to veterans facing felony charges. This treatment modality strives to prevent recidivism and promote accountability and recovery by diverting participants through a multi-phase recovery/ treatment program. Completion of the program awards participants a dismissal of their charges (1 year after graduation), pending continued recovery and probationary compliance.

Adjacent counties are in the initial phases of standing up similar versions of the VTC. Buncombe County VTC is scheduled to graduate two veterans at a 20 October 2023 Ceremony.
